Client

The client is a leading electricity supplier in the United Kingdom with a plant that generates enough electricity to power approximately 1.5 million homes and is linked to one of Europe's largest battery storage assets.





Key Challenges

- Separating complex business systems from a well-established parent organization
- Integrating with the permit system, seal print solution, and banks in a challenging environment
- Migrating data and setting up workflows with multi-level approval processes
- Implementing specific processes for finance business transactions and reporting
